## AGUNSA SIGNS PACT FOR WATER SECURITY

AGUNSA was one of the five companies that took part in the launch of the Water Security Pact, aimed at encouraging companies from different areas to reduce their water consumption in the value chain and creating high-level practices for its care.

According to figures from Fundación Chile, 76% of the country's surface is affected by droughts; therefore, this pact seeks to revert this reality and make Chile the first country to reach Water Security. In order to do so, associations such as ClimaTech Chile and the United Nation's Race to Resilience took the initiative so that private companies can contribute to reach this goal.

"We were aware of this Water Security Pact, which was in the lookout for precursor or pioneer companies on this

matter. And, at AGUNSA, as a logistics company, our goal is to become sustainability leaders in the country and in Latin America, so this opportunity is an excellent platform to demonstrate what we do and persuade the rest of the companies to join while serving as a model," stated our sustainability manager, Nicolás Calvo.



## AGUNSA AND TPV RECEIVE THE HUELLA CHILE SEAL

During a ceremony carried out by the Ministry for the Environment and Corfo, AGUNSA received—for the second year in a row—the Huella Chile certification. This indicates that we have reached the level of quantification of our direct and indirect greenhouse gases and other indirect gases at an organizational level. Furthermore, the Valparaíso Port Terminal obtained this recognition for the first time.

#### **AEXSA CELEBRATES ZERO ACCIDENT RATE**

AGUNSA's intermodal warehouse at the San Antonio port began operations in November 2018, and their accident rate has remained zero ever since, being this a milestone acknowledged by the Instituto de Seguridad del Trabajo (IST) [Hospital for Workers]. This achievement is the result of our compromise to identify and mitigate risks.

"We are proud and humbled to receive this recognition for the daily work carried out by each team, contributing to the self-care culture, the prevention and, ultimately, to the safeguard of every person external to the organization that visits the terminal on a daily basis, such as the carriers and contractor companies," stated Cristián Ibieta, AGUNSA Intermodal CEO.



#### I-REC CERTIFICATION: AGUNSA **DUPLICATES LAST YEAR'S RENEWABLE ENERGY CONSUMPTION**

In March 2023, we received the I-REC certificate, an internationally renowned instrument to attest the companies' reduction of carbon emissions, using the development of renewable energy as a way of reduction.

Our Puerto Montt office participated actively on the export operations of Ronia Austral and Ronia Pacific, two latestgeneration wellboats from Solvtrans Chile, that sailed bound for Alesund, Norway.

At the forefront of the main requirements of the Chilean salmon industry, wellboats are specialized vessels for the transport of live fish through a system of water circulation with their own tanks, pumps, oxygenation, disinfection, and loading and unloading processes. Given these characteristics, they are highly appreciated by the industry and subject to constant renewal.

Before their departure, both vessels had to change their Chilean flag to a Norwegian one, as well as their names to Ronja Dolstein and Ronja Settler.

This way, AGUNSA in Puerto Montt handled them as their port agents, providing services on their crew change, pilotage, launches, and overseas export.





















#### AGUNSA ARGENTINA SIGNS IMPORTANT CONTRACT WITH J&F MINERAÇÃO

Our office in Argentina announced the signing of contract with one of the biggest barge owners and main iron mineral transport for the Paraná-Paraguay waterway from the iron industry in the region, J&F Mineração.

Particularly, the service consists of the mooring of barges at the San Nicolás de los Arroyos Port, on the west-coast of the Paraná River. This value proposal is added to the main operation of loading and unloading of ships and/or barges at Ternium San Nicolás, managing their arrival to the port, mooring, and unloading.

## STARTS SERVICES FOR A NEW SOLAR FARM IN TALNIQUE

Under UDP Talnique society, AGUNSA will offer the handling of cargo, coordination, and execution of all the steps in the supply chain at origin and destination, as well as customs clearance and maritime agency services for the first solar farm of the Salvadorian State, Talnique Solar.

This farm will be able to generate renewable energy for 25 thousand homes from El Salvador that consume an average of 100 kWh, and it is expected to be fully operational by December 2023.

#### WE WERE PRESENT AT ARMINERA

We visited and participated in the most important fair in the Argentinian mining industry: Arminera. The event was carried out on May 22<sup>nd</sup>, 23<sup>rd</sup> and 24<sup>th</sup> and included the exhibition of the main actors from the lithium and local mining scenes. We used this opportunity to present our range of integral logistics, port, transport, and storage services. Moreover, we were the only operator there that offered these solutions for the Paraná-Paraguay waterway, and for the ports in the north of Chile.

#### PORTRANS IS ACKNOWLEDGED AS THE BEST COMPANY AT THE PROLOGITEC SUMMIT 2023

In June, the biggest logistics fair in Ecuador, Summit Prologitec, took place, gathering over 3 thousand executives, directors, and potential buyers of the transport and logistics industry in Latin America. We began the discharge service of new cars from China at our warehouse located at the Free Zone of Puerto Colón. The reception of containers and the storage of the first batch (105 cars) took place at AGUNSA's warehouse. We expect to receive five more batches, thus storing a total of 630 cars by the end of this year.

#### STARTS THE TRANSPORT AND STORAGE SERVICE FOR MINING **COMPANY ANTAMINA**

We have officially started the transport of OTR rims for Antamina, leading company from the Peruvian mining area. This service will have an execution period of five years and will use AGUNSA's own platform design, intellectual property of which was patented before INDECOPI.


This new platform design allows to carry six R63 tires horizontally, being these the heaviest, instead of just four or five, as it was the case with old platforms. The service seeks to move them from Callao to the Antamina mining site for several more years. We also developed a warehouse complex to manage our mining supplies for the same company.



#### AGUNSA PERU IS THE NEW LOGISTICS SERVICE SUPPLIER FOR DSM

By the end of May, in Paita city, the import and export Integral Services were carried out for the Dutch food and healthcare company, DMS. Throughout 2023, AGUNSA will be in charge of executing the services for terminal, container withdrawal, transport to the plant, customs agency, container return, approval, shipping and unloading at the port, for 40 containers on a monthly basis.







#### NEW INTEGRAL LOGISTICS SERVICE FOR **BACKUS**

In April, our team in Peru started the reception and delivery services for palletized cargo, storage, in-bond assembly, labeling, and export and import handling for the main beer company in the country, Backus. This allows AGUNSA to diversify its solutions to the food and beverages sector. Besides representing an opportunity to demonstrate its efficiency by providing safe operations and using information systems that allow precision in the management of cargo.



This, after AllCargoNet was acquired, company he used to chair. This way, it is expected to boost the operations in Miami and the south of Florida, in order to strengthen the opening gate of our operations in Latin American to the rest of the country.

Furthermore, AGUNSA USA is in the process of launching new lines of business as maritime agency to expand our service range and provide integral solutions to our customers. Moreover, in the marketing area, the company is carrying out a campaign to solidify its image in the market.

#### LEADERS IN THE MINING INDUSTRY: OUR PATH TOWARDS SUCCESS

In the last few months, we have started new contracts with the main mining companies in Chile and Peru, such as: Teck, BHP, Collahuasi, Codelco, Anglo American, and Antamina. This way, we continue consolidating the mining industry as a fundamental part of our company.

In the Tarapaca region, we started the maritime maintenance contracts for the Port Terminal and the Teck QB2 Desalinization Plant, as well as the engineering contract of detail, supply, and assembly of the cathodic protection system for the Collahuasi Port.

In addition, our facilities in the north and center of the country are being used by several mining companies, positioning us as the main

alternative to carry out the logistics of tipping containers and oversized cargo. In the last month, we have transported over 2 thousand containers of this kind.

Likewise, we have experienced a sharp increase in road transport for the industry, with short and long-term contracts, for general, oversized cargo and bulk mining products. We were also allocated transport services for copper concentrate in different areas of the country, for national sale and export.

"I would like to congratulate our commercial and operational team for the work done in the implementation of contracts. Our long-term

strategy, implementation of technological systems and the planning of each operation, allows us to carry out services of different nature simultaneously and with world-class standard," stated Tomás Valenzuela, Mining and Energy Manager.

Our growth in the mining industry has not only been at national level, but we have also managed to start a contract in Peru for the transport service of OTR rims for the prestigious mining company Antamina, a worldwide referent in mining, as their copper production is the fourth largest in the world.

"The solution implemented by AGUNSA for Antamina is unique in the market, as we achieved an efficiency increase of between 30% and 50% for each project, which translates into tangible benefits for the mine, the environment and the communities," stated Bruno Aberasturi, Mining Manager in Peru.

As a company we will continue implementing our long-term growth strategy, making important investments, and delivering highstandard solutions for our customers.



Our drones collect data through numerous RGB, thermal and multispectral sensors that allows the identification of critical variables to be controlled and, therefore, minimize risks on the customers' business

#### **Data Analytics using Artificial Intelligence.**

We have created alliances with the main data analytics companies in the world, in order to generate personalized reports for our energy and agriculture customers. We use field information and train algorithms with Artificial Intelligence.

#### Our services

#### Energy

We have inspected over 1,760 MW of photovoltaic panels and over 120 wind turbines on wind farms. Our strategy and business model focus on tackling 20% of the entire Chilean market by 2025.

#### Agriculture

We are developing the inspection service for vineyards and citric plantations. We deliver a geospatial review of the state of the crops and plantations that allows us to identify deficiencies and, therefore, reduce the production cost per hectare.

#### Security

Four years ago, we offered Preventive Telesurveillance services with drones to different Regional Presidential Delegations in Chile. These services can also be applied to private companies to prevent crime.





#### LETTER FROM INVITED MANAGEMENT

The airports and investment area was created in 1997, due to the continuing interest of our Board of Directors to expand AGUNSA's businesses and its participation on the logistics chain, integrating new operations and markets.

Thus, the following year our company, alongside companies Dragados, YVRAS, SABCO and FCC International, was allocated the concession of the Arturo Merino Benítez (AMB) Airport in Santiago, becoming a guide for later concessions.

Our unit is characterized for being in a constant search for new opportunities. In 2003, we were awarded the concession of the Montego Bay airport in Jamaica, with a consortium formed by Dragados, YVRAS and Ashtrom, taking an important step on the internationalization of the area. Later, we were awarded the concessions of the airports in San Andrés island and Providencia Island in Colombia. There, we could continue developing our model for technical assistance and management of the operation.

During these years, we have strengthened our position as airport operator, achieving concessions in La Serena, Punta Arenas, Puerto Montt, Arica, and Calama, the latter being recently renewed alongside our partner Sacyr.

Also, within of our concessions, we counted with company ABX in consortium with BESALCO, that since 2016 is dedicated to the real estate management on the International Cargo Terminal area of the AMB airport. Here we deliver infrastructure for warehouses and offices, which main customers are customs agents, courier, international cargo companies, among others.

In 2019, and as a new way to continue strengthening our interaction with the airport operations, we started the aeronautic security areas, the development of specialized software



for the operational management of the airports, as well as a new unit for passenger services and ground handling with the most modern equipment fleet in Santiago. Consequently, we have customers such as Kalitta Air, United Airlines, Delta Airlines, Qatar Cargo, Korean Air Cargo, among others.

In 2020, the pandemic affected us just as the entire aeronautic industry, but thanks to a cohesive team with a strong service orientation, we could comply with all of our customers, being listed as an excellency provider.

As a result, in 2022, AGUNSA arranged a joint venture with Menzies Aviation Ltd, world-class leading company, to operate together both the Ground Handling and Cargo services.

Alongside them, we also operated our new cargo warehouse at the Santiago Airport, to complement the service to the importers.

Also, with a focus on innovation and new businesses, AGUNSA acquired IGNOUS, important

Chilean company, leader in Inspections and Preventive Telesurveillance services with drones. This alliance has allowed the development of new ways of inspection in the renewable energies area, exploring other markets as the telecommunication and agriculture sectors, both in Chile as well as abroad.

In this area we believe in the spirit of the publicprivate association, which is why we are actively evaluating and participating on concession tender processes for national and international airport infrastructure.
